- E. Be present for all official club/organization meetings and activities (business and social), and to advise students of the policies and procedures which they must follow as a club/organization.
- H. Ensure that all reasonable steps are taken to ensure the safety, and welfare of club members.
- I. Ensure that appropriate school policies are upheld.
- J. To sign all club/organization requisitions for the club/organizations, and to make sure that 1) their student treasurer or (co)president signs it and 2) that the expenditure is correct within all existing policies.
