Identified need in the goal. It was broken down into subgroups. The strategy and activity was described. Mr. Hundley asked a question regarding 80% of the whole school. It is only 3<sup>rd</sup>-5<sup>th</sup> grade students. Mrs. Cruz would like to know how parents can help students reach their goal. Mr. Strom stated that through guided reading, small group instruction and the writing component, student's goals should be met.</li> </ul>

Budget/SBB for 21-22 school year	<ul style="list-style-type: none"> <li>• Mr. Strom, Voting Item</li> </ul>	<ul style="list-style-type: none"> <li>• Webster would be down one classroom teacher for next year. We currently have 10 teachers this year. The Guidance Assistant position will be eliminated and converted to an Attendance Assistant. The position will be 3 hours to do attendance. There was a concern about the discipline since there will not be a Guidance Assistant. There is a District Counselor on site for one day a week. We are not able to increase the amount of days for the District Counselor because it is very expensive. Mr. Schweitzer made a motion to eliminate the Guidance Assistant position and replace it with an Attendance Assistant for the 21-22 school year. Mr. Strom seconded the motion. The vote was 6 in favor and 2 opposed.</li> </ul>
